## WAIVER, RELEASE & INDEMNITY AGREEMENT

To McGregor Links Country Club, its employees, directors, insurers, agents, successors, and assigns (collectively the "Club"). In consideration of being permitted to participate in and use the Club as a condition of my membership,

I \_\_\_\_\_, representing all parties in my membership (hereinafter the "Member") hereby agree as follows:

### PERSONAL PROPERTY

1) The club is not responsible for the loss or theft of or damage to personal property on the Club's premises. Whether held in storage or not. This includes but is not limited to golf clubs, golf bags, golf accessories, money or other property. The Member will take all precautions to avoid loss or theft of, or damage to, personal property. In the event of such loss, or damage, the Member agrees to hold the club harmless from and against any and all claims, actions, costs, expenses and demands in respect to such theft, loss or damage, however caused, arising out of or in connection with the use of the club.

### POWER CART RENTALS

2) The member agrees to assume all risk of loss or damage to motorized golf carts rented or borrowed from the Club as well as the risk of injury to the Member or other persons and damage to other property arising from the use of the golf cart. The Member will take all precautions to avoid loss or damage to the golf carts, damage to other property and injury to persons including to the Member arising out of the use of golf carts. In the event of any loss, damage or injury, the Member agrees to hold the Club harmless from and against any and all claims, actions, costs, expenses and demands in respect of such loss, damage or injury, howsoever caused. The Member agrees to indemnify and reimburse the Club for any liability, costs or expenses imposed by law upon the Club for any and all such losses.

### GENERAL WAIVER

3) The Member acknowledges that there are risks inherent in participating in the game of golf, tennis, pickleball or swimming in the pool. The Member agrees to release the Club from any liability from personal injury, property damage or loss sustained by the Member, including injury resulting in death and any financial loss or damage directly or indirectly resulting from the Member's activities or participation in events at the Club. The Member further waives as against the Club, all claims recourses and rights of action that the Member may have against the Club as a result of such personal injury, property damage or loss.

4) The Member agrees that this Waiver, Release and Indemnity Agreement shall not be affected by any negligence, gross negligence, breach of contract or any other conduct on the part of the Club.

5) The Member acknowledges that they have read this Waiver, Release and Indemnity Agreement and understands and accepts the contents hereof.

## 2024 GOLF MEMBERSHIP AGREEMENT FOR FINANCES AND CLUB RULES

I/We hereby apply for membership at McGregor Links Country Club. The specific financial details regarding membership dues and house account charges have been explained and are understood and agreed to:

Dues for each seasonal year are based on the chosen membership. Dues must be paid in-full, 50/50 or on an automatic monthly plan. If you choose the monthly payment plan, you hereby agree to pay the full membership dues even if you leave McGregor Links for whatever reason before the end of the season.

If I choose to not leave a credit card on file, I understand I will not have a house account. This minimum applies to the months of April through October. If the minimum is not met the remaining balance due from the minimum will be automatically charged to the November invoice. Clubhouse restaurant expenditures include all food and beverage purchased at the turn, beverage cart and restaurant, excludes taxes and tips.

## McGregor Links Country Club Golf Membership Rules for 2024

### Dress Code

- Men's golf shirts are required to have collars and be tucked in. Golf shorts or pants. No jeans, jean shorts or cargo shorts/pants.
- Women's golf shirts are expected to be appropriate fashion tops. If it is sleeveless shirt, it should have a collar. No t-shirts, tank tops, cut offs, or denim are allowed. Golf skirts or shorts must be appropriate length.
- Golf shoes are required to have soft spikes; no metal spikes or open-toed shoes are allowed.
- Golf hats and caps must be worn properly with the brim facing forward. Hats should be removed in the restaurant.

### Conduct on property.

The Club reserves the right to refuse service to any member or guest who violates these rules.

Smoking. The Pro Shop, Range, Pool, Courts, and The Clubhouse are non-smoking facilities. Smoking is only permitted outside 15 feet away from the buildings. Please discard all cigarette and cigar butts in the ashtray receptacles provided by Clubhouse, Pro Shop and Pool.

Pets. With the exception of service dogs, pets are not permitted on the course, Clubhouse common areas, the practice ranges, pool, courts or in the buildings.

Personal Belongings. The Club shall not be held responsible to any member or guest for the loss of property of any kind. Lost items will be held in the Pro Shop, Pool or Office, and articles not claimed within 14 days will be disposed of or donated to an appropriate charitable organization.

Vehicles. Vehicles are permitted in authorized parking areas only. Bikes may be ridden on the cart path and parked at the pool.

Soliciting and Sales. The sale of any product or service and the solicitation of funds are not permitted on Club property. No posters, advertisements, publications, or notices shall be displayed or distributed on Club premises unless given permission by owners.

Safety and Accidents. The Club is concerned about the safety and well-being of all its members and guests. Members and guests should immediately report any act, situation or circumstance that is unsafe to a Club staff member. If any member or guest experiences an emergency of any kind, they should call 911, tend to the individual's needs, and seek help from a Club staff member. If any member or guest is hurt or has an accident on the premises, they should immediately notify the Club so that an incident report may be completed.

### Member Guest Passes, Rates and Round Limitations

- Member guest passes can be used at anytime and are valid for greens fees only.
- The Member who is using their Guest Pass or Guest Rate MUST be playing golf with the guest.
- Guest Passes are not valid unless said member is playing with them.
- *A member guest pass or rate can only apply to a specific Guest TWICE in a month, regardless of which member brings the guest.*
- Member's guests are permitted to play during weekend morning tee times as access permits. Priority to given to the members first.

### Tee Times

- Members may reserve tee times up to 7 days in advance. Subject to change.
- Public can reserve tee times 3 days in advance. Subject to change without notice.
- No shows and tee times cancelled without 24 hours are subject to a \$25 charge.

### Golf Instruction

Golf instruction is to be conducted by authorized McGregor Links Country Club instructors only.

### Food and Beverage

On Course: Outside coolers are not allowed. Outside alcohol is not allowed.

At Pool/Courts: Outside alcohol is not allowed. Outside coolers are allowed.

### Golf Carts

- Unlimited Carts purchase is for all cart usage throughout the season including leagues and club tournaments.
- Once a player checks in with Starter, or in Pro shop, they will receive key to a cart.
- A valid driver's license or permit is mandatory for golf cart rental.
- Groups must consolidate into a maximum of 2 carts per foursome of riding golfers.
- All No Cart signs are to be followed.
- Carts must exit to the nearest cart path.
- Golf carts may not travel within 30 feet of putting surfaces.
- Golf carts are not permitted to travel in the tall fescue grass areas.
- For safety, golf carts MUST be at least 30 feet away from the tee box and green.
- Members and guests operating a Club-owned golf cart will be held fully responsible for any and all damages to the golf cart or golf course while the cart is in their possession.
- Any negligent use or reported negligent use of golf carts in your possession will result in loss of golf cart privileges.
- Use extreme caution when crossing all public roads through course.
- Handicap cart flags/plaques will be available for those with a medical condition and pre-existing handicap license.

### Unlimited Trail Fee and use of Member Owned Carts

All personal golf carts utilized on the property must adhere to the following rules:

- Proof of insurance must be on file in the office (typically this is already covered under a home owners policy)
- A green, blue or red sticker, provided by the office, must be clearly visible on the back bumper of the golf cart at all times.
- Tires CANNOT be large all terrain tires. Must be **golf rated tires (regular tread)** in order to not destroy grasses on the property.
- You will be held responsible for any and all damages (outside of regular wear) to the golf course and extending property caused by your golf cart.

There are 3 types of usage for personal golf carts on the property for members:

**An Unlimited Trail Fee** can be purchased for the season. This covers all persons included in the membership type for use of cart at all times on the course including leagues and tournaments. The office will provide a **GREEN** sticker for your cart. *Guests that ride on a personal cart will be charged a \$20 cart fee.*

**Pay as you Trail Fee** can be established for the season. This is for the member who chooses not to purchase an Unlimited Trail Fee and wants to use their personal golf cart on the course for playing golf. *A reduced cart fee of \$15 for 18 holes and \$10 for 9 holes per person will be charged for each person in your cart associated with your membership. Guests that ride on a personal cart will be charged a \$20 cart fee.* A **RED** sticker, provide by the Office, must be clearly visible on the back of bumper of your golf cart.

**Riding to Pool, Courts and Restaurant** This is for personal use of your golf cart for going to the pool, courts and restaurant. A **BLUE** sticker, provided by the Office must be clearly visible on the back bumper of your golf cart.

Push Carts are NOT allowed on tee boxes.

- Push carts are NOT allowed on the putting greens.
- Push carts are NOT permitted in the tall fescue grass areas

### Pace of Play

- Play is expected to be at a pace of 15 minutes per hole or less, or 4½ hours to complete 18 holes.
- Each group should keep pace with the group ahead of you.
- **Players should not spend more than 3 minutes searching for golf balls that are lost or in water hazards.**
- As a courtesy, groups should allow faster groups, including singles, twosomes, and threesomes, to play through at the earliest opportunity.
- **McGregor Links Country Club reserves the right to move groups into position if they consistently fail to recognize pace-of-play concerns.**

### Handicaps

- NY GHIN, either 1 or 2, are included with all memberships
- Additional NY GHINs can be purchased in the office
- Every member who plays in league or tournaments MUST have a NY GHIN. GHINs purchased in other states cannot be used in the NY GHIN system, per state rules.
- Handicap rules apply
- **Every member is responsible for posting scores on the GHIN app.**
- **Members should post all rounds: home and away**

### Golf Course

- USGA rules govern play except where amended by the McGregor Links Country Club Local Rules set forth at the beginning of each season and subject to change without notice.
- All players are required to have their own golf club sets; players are not permitted to play out of the same bag. Clubs are available for rent in the pro shop.
- Fivesomes are not permitted without the permission of the golf shop staff.
- **Golfers 12 and under must be accompanied by an adult (18 years or older) who is responsible for the children's actions.**
- Golfers must repair ball marks on putting surfaces.
- Golfers must rake all bunkers.
- Players should fill divots with a sand mixture or replace the divots.

### Practice Areas: Driving Range, Putting Green, Chipping area

- Children under 13 must have adult supervision in all areas.
- Appropriate footwear is required for all guests. No open-toed footwear is allowed
- No pushcart or golf carts allowed on the chipping/putting area
- Proper golf attire required in all areas.
- Driving Range.
  - Unlimited Driving Range packages are available.
  - You may not retrieve any balls from the Driving Range.
  - One person per tee/stall
  - Tokens for range balls are obtained at the Pro Shop and may not be removed from property.
  - For your safety, walking on the tee strip behind a hitting area is strictly prohibited

### Weather Policy

- Severe Weather: The golf shop will sound the warning horn with two long blasts when severe weather is approaching. All golfers on the course MUST immediately return to the turn, pro shop or clubhouse to seek shelter.
- Common sense should always prevail, if you hear thunder or see lightning but do not hear the horn proceed to the nearest shelter immediately.
- If a group tees off in the rain, and the course closes due to weather, no raincheck is issued.

- *Playing 9 holes:* If you play less than 5 holes, and course is closed due to weather, you will be issued a raincheck.
- *Playing 18 holes:* If you play less than 9 holes, and course is closed due to weather, you will be issued a raincheck, 13 or more holes there will be no refund.

### **POOL RULES AND REGULATIONS**

- Must sign in when entering the pool
- No swimming without lifeguards on duty
- No running, horseplay, pushing or dunking
- Adults are responsible for the supervision of their children
- No one over 6 years old is allowed in the kiddie pool at any time
- No playing with the water spout in the kiddie pool
  - If spout is covered or water spray is inhibited in anyway the pump will SHUT OFF which may require both pools to be closed in order to monitor and reset the pumps
- Proper swim wear is required
- No one under the age of 13 is allowed in the pool without parental supervision
- Cement pad is off-limits. No playing, sitting, laying, etc., on cement pad outside of pool house
- No gum allowed inside pool gate
- At the first sign of lightning, everyone must be out of the pool. By law, the pool cannot reopen for 30 minutes after last sign of lightning.
- Members may bring 2 guests to the pool at one time for \$10 per person fee. Member must remain with guests at all times.
- If you have out of town guests, please contact the office for additional passes

### **RACQUET COURT RULES AND REGULATIONS** (pickleball & tennis only played on courts)

- No member may occupy two courts with guests at anytime. Guest fee is \$10 per person
- Court etiquette and being courteous to the players is required while playing on the courts
- Tennis shoes are the required footwear.
- Shirts must be worn at all times. Bathing attire is not permitted.
- No pets.
- No bicycles, roller blades or skateboards.
- Sitting or leaning on the nets is prohibited.
- Place all debris in trash receptacle provided.
- Children using the courts, age 13 and under, must be under supervision of an adult member at all times who is responsible for all behavior
- Report any maintenance issues to either the pool check in staff or call the office

**Pets.** With the exception of service dogs, pets are not permitted on the course, Clubhouse common areas, the practice range, pool, courts or in the buildings.

**Personal Belongings.** The Club shall not be held responsible to any member or guest for the loss of property of any kind. Lost items will be held in the Pro Shop, and articles not claimed within 14 days will be disposed of or donated to an appropriate charitable organization.

**Vehicles.** Vehicles are permitted in authorized parking areas only. Bikes may be ridden on the cart path and parked at the pool.

**Soliciting and Sales.** The sale of any product or service and the solicitation of funds are not permitted on Club property. No posters, advertisements, publications, or notices shall be displayed or distributed on Club premises unless given permission by owners.

**Safety and Accidents.** The Club is concerned about the safety and well-being of all its members and guests. Members and guests should immediately report any act, situation or circumstance that is unsafe to a Club staff member. If any member or guest experiences an emergency of any kind, they should call 911, tend to the individual's needs, and seek help from a Club staff member. If any member or guest is hurt or has an accident on the premises, they should immediately notify the Club so that an incident report may be completed.

### **RACQUET COURT RULES AND REGULATIONS** (pickleball and tennis only played on courts)

- No member may occupy two courts with guests at anytime. Guest fee is \$10 per person
- Court etiquette and being courteous to the players is required while playing on the courts
- Tennis shoes are the required footwear.
- Shirts must be worn at all times. **Bathing attire is not permitted.**
- No bicycles, roller blades or skateboards.
- Sitting or leaning on the nets is prohibited.
- Place all debris in trash receptacle provided.
- Children using the courts, age 13 and under, must be under supervision of an adult member at all times who is responsible for all behavior
- Report any maintenance issues to either the pool check in staff or call the office
