WAIVER, RELEASE & INDEMNITY AGREEMENT

being permitted to participate in and use the Club as a condition of my membership,
I, representing all parties in my membership (hereinafter the "Member") hereby agree as
follows:
PERSONAL PROPERTY
I) The club is not responsible for the loss or theft of or damage to personal property on the Club's premises. Whether held in storage or not. This includes but is not limited to golf clubs, golf bags, golf accessories, money or other property. The Member will take all precautions to avoid loss of theft of, or damage to, personal property. In the event of such loss, or damage, the Member agrees to hold the club harmless from and against any and all claims, actions, costs, expenses and demands in respect to such theft, loss or damage, however caused, arising out of or in connection with the use of the club.
GENERAL WAIVER
3) The Member acknowledges that there are risks inherent in participating in the game of golf, tennis, pickleball or swimming in the pool. The Member agrees to release the Club from any liability from personal injury, property damage or loss sustained by the Member, including injury resulting in death and any financial loss or damage directly or indirectly resulting from the Member's activities or participation in events at the Club. The Member further waives as against the Club, all claims' recourses and rights of action that the Member may have against the Club as a result of such personal injury, property damage or loss.
4) The Member agrees that this Waiver, Release and Indemnity Agreement shall not be affected by any negligence, gross negligence, breach of contract or any other conduct on the part of the Club.
5) The Member acknowledges that they have read this Waiver, Release and Indemnity Agreement and understands and accepts the contents hereof.
6) In the event that any provision herein contained is deemed to be unenforceable and/or invalid that the provisions shall be severable from the whole of the document and shall not affect the validity and enforceability of the other provisions and the document as a whole.

Pool & Courts General Club rules for 2025

<u>Food and Beverage</u>. Golf course: Outside coolers are not allowed. Outside alcohol is not allowed. Pool/Courts: Outside alcohol is not allowed. Outside coolers are allowed.

Conduct. The Club reserves the right to refuse service to any member or guest who violates these rules.

<u>Smoking.</u> The Pro Shop, Range, Pool, Courts, and The Clubhouse are non-smoking facilities. Smoking is only permitted outside 15 feet away from the buildings. Please discard all cigarette and cigar butts in the ashtray receptacles provided by Clubhouse, Pro Shop and Pool.

<u>Pets.</u> With the exception of service dogs, pets are not permitted on the course, Clubhouse common areas, the practice range, pool, courts or in the buildings.

Personal Belongings. The Club shall not be held responsible to any member or guest for the loss of property of any kind. Lost items will be held in the Pro Shop, and articles not claimed within 14 days will be disposed of or donated to an appropriate charitable organization. Vehicles. Vehicles are permitted in authorized parking areas only. Bikes may be ridden on the cart path and parked at the pool.

Soliciting and Sales. The sale of any product or service and the solicitation of funds are not permitted on Club property. No posters, advertisements, publications, or notices shall be displayed or distributed on Club premises unless given permission by owners.

Safety and Accidents. The Club is concerned about the safety and well-being of all its members and guests. Members and guests should immediately report any act, situation or circumstance that is unsafe to a Club staff member. If any member or guest experiences an emergency of any kind, they should call 911, tend to the individual's needs, and seek help from a Club staff member. If any member or guest is hurt or has an accident on the premises, they should immediately notify the Club so that an incident report may be completed.

POOL RULES AND REGULATIONS

- Must sign in when entering the pool.
- No swimming without lifeguards on duty.
- No running, horseplay, pushing or dunking.
- Adults are responsible for the supervision of their children.
- Children in the kiddie pool and children with flotation devices must be supervised by a responsible adult at all times.
- No playing with the waterspout in the kiddie pool.
 - If spout is covered or water spray is inhibited in anyway the pump will SHUT OFF which may require both pools to be closed in order to monitor and reset the pumps.
- Proper swim wear is required.
- No one under the age of 13 is allowed in the pool without parental supervision.
- Cement pad is off-limits. No playing, sitting, laying, etc., on cement pad outside of pool house.
- No gum allowed inside pool gate.
- •At the first sign of lightning/thunder, everyone must be out of the pool. By law, the pool cannot reopen for 30 minutes after last sign of lighting/thunder.
- •Members may bring 2 guests to the pool at one time per day for a fee of \$10 cash per guest. Member must remain with the guest at all times.
- •If you have out of town guests, please contact the office for additional passes at \$10 each.

RACQUET COURT RULES AND REGULATIONS

- •No member may occupy two courts with guests at any time. Guest fee is \$10 cash per person payable at the pool or office.
- Court etiquette and being courteous to the players is required while playing on the courts. Courts are to be used for tennis or pickleball only.
- •Tennis shoes are the required footwear.
- Shirts must be worn at all times. Bathing attire is not permitted.
- No pets, bicycles, roller blades or skateboards.
- Sitting or leaning on the nets is prohibited.
- Place all debris in trash receptacle provided. Report any maintenance issues to the pool staff or call the office.
- Children using the courts, age 13 and under, must be under direct supervision of an adult member who is responsible for all behavior.
